Review of status of Grant Proposals – Ellis:

The total cost for the water cistern (10,700 gal.) is quoted to be \$23,804.93 by Water Net Inc. Ellis moved that we pursue putting in a new water cistern and Adrienne seconded the motion. The motion was unanimously accepted by the Board.

Ellis will send the spec sheet out to get additional quotes from other contractors for comparison to the quote submitted by Water Net Inc. He will request that bids be submitted by October 1<sup>st</sup>. The Board will choose the contractor during the October 6<sup>th</sup> Board of Trustees Meeting.

Roy and Ellis met with Ms. Sattler regarding a USDA grant. We will need certified drawings for the new building and a determined life expectancy from an architect to pursue this grant. Ellis will pursue the USDA grant as well as another from FEMA.

Identification of the sources for fire fighter training – Jerry provides First Aid Training, the Montana State University Fire School, the Lewis & Clark Fire Council and the DNRC provide Wild Land Fire training. Ron Turigliatto is proficient in Structure fires and Wild Land fires.

Ells motioned to adjourn the Board of Trustees Meeting and Louise seconded the motion. The motion was passed unanimously by the Board. The meeting was adjourned at 11:37 a.m.
